Flash ARIA - Hazardous waste: beware of incompatibilities!



Accidents associated with incompatible mixtures do not involve only new chemical products! Products near the end of their lifecycle are also a source of accidents. This is reflected in several recent events, both in France and abroad, which have had dramatic consequences. This flash focuses on this problem by detailing the malfunctions that cause accidents and proposes recommendations on how to prevent them from occurring.

Synthesis - Manufacturing vegetable oils: a risky business



The many steps involved in manufacturing vegetable oils are susceptible to accidents. From the very start of the process, the reception of grain and its storage mean heating and fermentation are likely, and the accumulation of dust increases the risk of fire and explosion. The transport of grains, pellets and cakes obtained at the end of the process, the various steps of the oil extraction process in which hexane is used, and the crude oil refining process are also accident risks.

Accident report - Improving safety through feedback

ARIA 48294 - 13/07/2016 - UGINE (73)



This accident, which occurred in a metallurgical plant, highlights the feedback work, undertaken by an operator after one of its ovens exploded. The work undertaken to understand why this event occured allowed several organizational causes to be identified. The resulting aprovements focus on the root causes and have thus made it possible to sustainably improve safety at the site.
